



(i)	Basic Fabrics:- Common proofed canvas/duck shall be made from canvas as per IS+1422/1983.		Rs. 77.50 (Rs. Seventy Seven & Fifty Paise Only.)
(ii)	Common Proofing:- Common proofing mixture shall be prepared with the ingredients consisting essentially of Paraffin Wax, a suitable pigment and aluminium stearate.		
(iii)	Common Proofed Canvas Duck:- The common proofed canvas/duck shall be such that common proofing shall be between 40 to 75 % of the mass of base fabric when tested as prescribed.		
(iv)	Resistance to Microbial Attack:- The material shall be rendered resistant to microbial attack by treating with suitable rot proofing agent. The proofed material when tested by the pure culture mixed culture, as pregillusniger and soil burial methods prescribed in IS Specification.		
(v)	Chemical Requirements:- Pliability sweating test, breaking strength, water-proofness, cone test, shall confirm as prescribed in IS Specification		
(vi)	Sewing Thread:- Twine whipping shall be as prescribed in IS Specification.		
(vii)	Eyelets:- Aluminium Alloy NS3 or NS4 or brass eyelets strictly as per to size 30 of IS-4084-1967 as laid down standards.



(1)	Manufacture:- Common proofed tarpaulins (tarpaulins) shall be made to the shade and dimensions with panels of even tone as far as possible.	
(2)	Construction:- The panels shall be flat (lap) joined , it may also be hook joined, if specifically required by the consignees.	
(3)	Fixing of Eyelets:- The eyelets shall be fixed at an interval of above 150 cms. all sides. The eyelets shall be fitted in row and shall comply to IS specification.	

1. Rates :- F. D. Destination.
2. Taxes:-
 - i) VAT :- Inclusive.
 - ii) Excise Duty: - Inclusive.
 - iii) Octroi:-Nil against octroi exemption certificate. Octroi will be charged extra to those departments who will not provide octroi exemption certificate
 - iv) Packing:- Packing should be standard and acceptable to railway Authority and Govt. Insurance fund.
 - v) Insurance:- Inclusive.
3. Delivery Period: - Within 4 weeks from the date of receipt of confirm order. Delivery period will be counted from the date of purchase order complete with octroi exemption certificate/Taxes concessional form etc.
4. Inspection : By Consignee at Destination, consignee must verify the ISI Mark.
Marking: Each Tarpaulin shall be legibly marked with the following information at one corner on one side by printing on it with the Ink
 - a) **Indication of the source of Manufacture,**
 - b) **Size and**
 - c) **Year of Manufacture.**
 - d) **The tarpaulin must be marked with the standard ISI mark.**
5. Payment : 90% payment within 15 days from the date of receipt of stores and balance 10% within 30 days from the date of receipt of stores in satisfactory condition as ordered.
6. This rate contract is meant for whole of Maharashtra.
7. Terms : All General Terms and Conditions will also be applicable As per rate contract.
8. Rate contract holder should submit monthly statement of orders received and executed to this office by 10th of every month without fail.
9. The Indenting Officers of Govt. Department shall place orders with the firms and should send copies thereof to this office.
10. Consignees should intimate of complaints if any within six months from the date of receipt of stores.
11. No Price Escalation will be allowed.
12. Warranty : One year warranty from the date of receipt of Canvas Tarpaulin.



13. The delay in supply should be worked out as per provision in "Manual of office procedure for Purchase of stores vide G.R.dt.21-02-1978 and penalty calculated should be deducted from the bill before payment.
