10. Force Majeure Clause is not applicable.

12. The firm will take a guarantee for the availability of spares part and consumable for period of 7 years.
13. As soon as Consignee/Indentor receives the machine he may intimate rate contract holder branch office so that they may depute engineer for installation and commissioning of the fax machine at the earliest free cost.

14. Training : Free training facility shall be provided.
15. All General Terms and conditions will also be applicable.
16. Comprehensive Service Contract: In this contract at a fixed rate per annum, will replace all required spares and provide service for a period of one year. Consumable will charge extra as mentioned in schedule. The rates are applicable for three years.
