

Visit of delegation of Government of Maharashtra to initiate the process of purchasing of 10 King Henry's Road, NW-3, and London UK Dr.Babasaheb Ambedkar's Former Residence, to be held from 23rd April, 2015 to 28th April, 2015.

PREAMBLE:

Government of Maharashtra passed a resolution on 3rd February, 2015 to purchase 10 King Henry's Road, NW-3, Dr.Babasaheb Ambedkar's Former Residence in London, where he lived in 1921-22 while studying in London School of Economics & Grej Inn and issued a G.R. Dated 16th February, 2015. In this meeting Government of Maharashtra has appointed a committee headed by Hon'ble Minister for Social Justice and Special Assistance to complete the purchasing process. Government of Maharashtra has also appointed a solicitor M/S.Seddons, London to complete the purchasing process. Hon'ble Chief Minister has approved the visit of delegation headed by Mr.Rajkumar Badole, Hon'ble Minister of Social Justice and Special Assistance alongwith Mr.Dilip Kamble, Hon'ble State Minister of Social Justice and Special Assistance and Mr.Ujjwal Uke, Principal Secretary, Social Justice & Special Assistance Department, to extended visit to London,

UK from **23rd April, 2015 to 28th April, 2015.** Previously the visit was sanction for the period 17th to 21st April, 2015.

Resolution: Permission is hereby granted,

1. To the visit of the delegation under the leadership of Mr.Rajkumar Badole, Hon'ble Minister of Social Justice and Special Assistance, and consisting of following members to initiate the process of purchasing of 10 King Henry's Road, NW-3, London, Dr.Babasaheb Ambedkar's former residence in London. : -
 - i. Mr.Dilip Kamble, Hon'ble State Minister of Social Justice and Special Assistance
 - ii. Mr.Ujjwal Uke, Principal Secretary, Social Justice & Special Assistance Department
2. The delegates are also permitted to avail 22nd April, 2015 to 29th April, 2015 for traveling and pre-arrangement.
3. The entire period of their visit shall be treated as a period of deputation / on duty.
4. The following are the Terms and Conditions of the participation in respect of delegates.
 - i. They will be entitle to draw the full pay and allowances, which they would have drawn, had they remain on duty in India.
 - ii. They are entitling for incidental expenditure to meet local costs on Passport Fees, Medical Certificates and Expenditure of Traveling upto Port of Embarkation in India, from place of their duties and from the Port of Disembarkation in India to the place of their duty, Airport Authority etc.
 - iii. The entire expenditure of the said tour will be borne by Department of Social Justice and Special Assistance, Government of Maharashtra, through Mahatma Phule Backward Class Development Corporation, Mumbai, the corporate body working under Social Justice and Special Assistance Department, Government of Maharashtra. The expenditure will be reimbursed to the Mahatma Phule Backward Class Development Corporation, Mumbai later on by Department of Social Justice and Special Assistance, Government of Maharashtra.

- iv. They are entitle for T.A./D.A. for the entire period of their visit to London, UK as per Government Rules.
5. The delegation is requested to observe the following guidelines to extend feasible.
 - 1 The delegation/visitors are requested to keep the Indian Mission/Post inform of the programme and the outcome of the visit.
 - 2 The member of the Mission/Post should be included for the formal meetings with foreign authorities, where a Minister or Secretary leads delegation, the Head of the Mission/Post should invariably be shown as a member of the delegation : and
 - 3 Adequate fund should be carried out by the delegation for meeting expenditure if any OR a copy of financial sanction issued by competent authority should be carried out along with in case of official visit.
6. The permission is granted by Department of External Affairs, Government of India to visit to London, U.K. in this regard.
