Extension of Gaothan give to population pressure and resettlement of persons of affected on threathened by floods

The scheme of extension of village is primarily implemented for following 3 reasons.

- (i) Extension of gaothan due to population pressure in rural areas.
- (ii) Resettlement of Nomadic Tribes, Ex-Criminal Tribes, backward class communities in rural areas.
- (iii) Resettlement of persons affected or threatened by floods applicable to both rural and urban areas.

The first two sub-schemes are planned schemes and the third one is non-plan scheme.

The following categories are eligible for plot of land as desired below :-

Category	Area
1. Agriculturist	3000 to 6000 Sq.Ft.
2. Laboures including village artisan and fishermen.	1500 St. Ft.
3. Backward Class Persons	1500 Sq.Ft. (Free of Cost)

Where suitable Govt./Village Panchayat land is available, the same is assigned for extension of Gaothan for the implementation of the above scheme and where suitable land is not available private land is acquired for the purpose.

For implementation of this Programme an outlay of Rs. 164.94 lakhs has been approved for General (Non-Tribal) and Rs.19.66 lakhs to Special Component Plan (S.C.P.) for the years 2004-2005, out of which Rs. 41.75 lakhs for General (Non-Tribal) and Rs. 6.48 lakhs to Special Component Plan (S.c.P.) has been budgeted for the year 2004-2005.
