## ANNEXURE-I

### **TERMS AND CONDITIONS FOR DISPOSAL OF VEHICLES AGAINST OFFICER ORDER - NO.उमविम/प्रशा/शावा क्र.4004/निर्लेखन/270,दि.19/9/2018.**

Interested Parties may submit their highest prices for each vehicle individually in a sealed cover latest by 1500 hrs on or before **26.11.2018**. The inner cover containing quotations and other relevant documents alongwith DD/Pay Order/Banker's Cheque towards EMD should be sealed properly. The cover should be put in another Outer Cover and may be dropped in the Tender Box of office premises(Establishment Section) Development Board for the Rest of Maharashtra,Mumbai. 18<sup>th</sup> floor, New Administrative Bldg,Opp Mantralaya,Mumbai-32. Both the inner and the outer covers should be superscribed in Bold Capital letters "QUOTATIONS FOR DISPOSAL OF VEHICLE".

2. The disposal of vehicle shall be strictly on " AS IS WHERE IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by this office. The condition of the vehicles can be inspected physically on any working day from 19.11.2018 to 22.11.2018 between 1500 hrs to 1600 hrs at Development Board for the Rest of Maharashtra,Mumbai,18<sup>th</sup> floor, New Administrative Bldg, Opp Mantralaya,Mumbai-32 (Tel: 22845598/22845599).

3. The quotation should be accompanied by earnest money of Rs.2,000/-The earnest money can be deposited by Bank Draft in favour of Administrative Officer Cum Research Officer, Development Board for the Rest of Maharashtra,Mumbai The bank draft should be attached with the quotation letter failing which the quotation shall not be considered at all. If the highest tenderer/successful tenderer accepted by the competent authority in this office fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited. In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.

4. EMD amount is payable by means of DD/Pay Order/Banker's Cheque in favour of Administrative Officer Cum Research Officer, Development Board for the Rest of Maharashtra,Mumbai (Payment by Cheque/Cash shall not be accepted).
